## Local Revenue Measures March 2007

A relatively few number of local governments placed ballot measures on the March 6, 2007 special election. Among the nineteen measures we have identified, fourteen concerned local agency taxes and financing. Six measures were proposed by cities, five by special districts and three by schools. All but two of the measures were 2/3 vote parcel taxes, including all three school measures and all five special district measures. There were two majority vote city Utility User Tax (UUT) measures.

All but one of the twelve parcel tax measures, achieved the 2/3 vote needed for passage, including all four city measures and all three school measures. In Calaveras County, the Bar XX County Service Area #2 fell seven votes short of the 56 needed to pass the proposed \$1,816 annual special tax for road maintenance. Each of the three 2/3 vote school parcel tax measures passed.

A majority of voters in the City of South Pasadena agreed to extend the city's 5% UUT, but voters in the City of Covina rejected a ten year extension on that city's 6% UUT.
