# Local Revenue Measure Results November 2019

On Tuesday November 5, 2019, California voters cast ballots on 45 local measures including 32 measures to increase or extend local taxes or bonds. Just four failed.


Among the 32 fiscal measures at this election, more than half, 22, were for cities, including 16 majority vote general taxes, one general obligation bond for affordable housing (in San Francisco), and one special tax on ride-share businesses for public transit (San Francisco).

There were 14 parcel taxes (two-thirds vote) including four by cities, five by special districts and five by schools.

Among the 16 city majority vote general tax measures were nine sales tax increases or extensions, four hotel occupancy tax increases and nine business license taxes, and three business tax increases including two on cannabis.

There were no countywide measures or school bonds.

## **Proposed Local Tax Measures**






With all votes counted and the results certified. 28 of the 32 tax or bond measures passed.



### **Local Add-On Sales Taxes (Transaction and Use Taxes)**

Voters in 9 cities considered general purpose majority vote add-on sales tax rates ranging from 1/2 percent to one percent. Two of these were extensions of existing taxes beyond a sunset date. Eight passed. The Claremont measure was the only majority vote general purpose measure to fail in this election.

#### **Parcel Taxes**

Among the 15 parcel taxes were five for schools, including two measures from the small wealthy enclave of Piedmont near Oakland. Voters in the Piedmont Unified School District (K-12) approved the extension, for eight years, of the highest school parcel tax in the state. In addition, they approved a new tax on building improvements, the first of its kind for a school district. The other three school parcel taxes were also in relatively wealthy areas in Marin and San Mateo counties. Only the Redwood City Schools measure failed - and narrowly.

Among non-school measures, there were five for fire and emergency medical services provided by small special districts plus an extension of an existing tax for fire, emergency medical and police services in the City of San Marino. Two cities and one special district parcel taxes were for parks and recreation services, including an extension of an existing tax in El Cerrito. Fairfax voters approved an extension of that city's parcel tax for various services. Voters in nearby San Anselmo soundly rejected a new tax for parks.
